OVERVIEW

The Beauty Therapy sector is a trusted and rapidly growing area within the Hair & Beauty industry. Beauty Therapists play a vital role in delivering a range of treatments to clients, ensuring satisfaction, professionalism, and safety at all times.

Working independently or as part of a wider salon or spa team, Beauty Therapists are responsible for providing essential beauty treatments that support both the client's wellbeing and the organisation's success. Apprentices will learn to maintain high standards of hygiene, customer service, and presentation while promoting the business's image and reputation.

Upon successful completion of the Level 2 Beauty Therapist Apprenticeship, individuals can progress into a variety of specialisms such as Fashion Make-Up, Media and Theatrical Make-Up, Bridal Make-Up, Nail Services, Spa Therapy, or Beauty Retail.

WHAT TO EXPECT

- As an internal apprentice attending one of our academies, you will have approximately 65 sessions in total that will take place weekly at one of our academies.
- Our educators have many years of hands on experience within the industry giving them the knowledge to support you
 every step of the way. Educator sessions are there to discuss your progress, assign you tasks and prepare you for
 your apprenticeship assessment.

ENTRY REQUIREMENTS

Individual employers may set their own entry requirements. The apprentice must already be employed for over 16 hours per week.

- If a candidate is 16-18 they must have achieved maths and English at Level 2 prior to completion of the course, this is something that can be completed with us if needed.
- If a candidate is 19+ and hasn't achieved in Maths and English GCSE before enrolling, it is up to the employer to decide whether these qualifications should be attempted.
- The candidate must be employed in a suitable role.

COURSE CONTENT

Beauty Therapists will learn to deliver a range of beauty treatments and services safely and professionally, while providing excellent client care and maintaining high industry standards. Apprentices will develop the following key knowledge, skills and behaviours:

- Deliver a range of beauty treatments including facials, waxing, eyelash and eyebrow services, make-up application, basic massage, manicure and pedicure.
- Conduct thorough client consultations using questioning, listening and observation techniques to meet client needs.
- Apply safe, effective and hygienic working methods, following health, safety and legal requirements.
- Demonstrate professionalism, integrity and commitment to quality and client satisfaction.
- Communicate effectively with clients and colleagues, adapting to different situations with empathy and respect.
- Manage time and workload efficiently while maintaining a calm and positive approach under pressure.
- Promote sustainable working practices and maintain confidentiality at all times
- Reflect on performance and continue developing technical and professional skills.

APPRENTICESHIP ASSESSMENT

The Apprenticeship Assessment includes:

- · A 40 question knowledge test to be completed within 60 minutes
- · A practical assessment lasting 5 hours
- For the practical assessment learners will be required to source their own models and demonstrate a range of services against industry and occupational standards and timings.
- Practical assessments and observations will take place for professionalism and values; safe working practices; waxing services; hand, nail & foot treatments; eyelash & eyebrow treatments; applying make-up and basic massage treatments. Candidates will also be required to have completed consultations with advice and aftercare demonstrated.
