OVERVIEW

An Advanced Beauty Therapist works within a range of professional settings, including salons, spas, clinics, leisure facilities and aesthetic environments. Building on their existing beauty therapy expertise, they deliver and design bespoke, results-driven treatment plans that meet client needs and expectations.

This role requires the use of advanced technical therapies such as facial and body electrical treatments, while ensuring all services are carried out safely, professionally and in line with organisational standards. Advanced Beauty Therapists contribute to the financial performance and operational success of the business, maintaining resources effectively and supporting sustainable working practices.

In addition to providing high-quality treatments, they may also take on supervisory or mentoring responsibilities, supporting the development of others and promoting a positive team culture that enhances the client experience and drives business growth.

WHAT TO EXPECT

- As an internal apprentice attending one of our academies, you will have approximately 52 sessions in total that will take place weekly at one of our academies.
- Our educators have many years of hands on experience within the industry giving them the knowledge to support you every step of the way. Educator sessions are there to discuss your progress, assign you tasks and prepare you for your apprenticeship assessment.

ENTRY REQUIREMENTS

Individual employers may set their own entry requirements. The apprentice must already be employed for over 16 hours per week.

- If a candidate is 16-18 they must have achieved maths and English at Level 2 prior to completion of the course, this is something that can be completed with us if needed.
- If a candidate is 19+ and hasn't achieved in Maths and English GCSE before enrolling, it is up to the employer to decide whether these qualifications should be attempted.
- The candidate must be employed in a suitable role.

Client Care & Preparation

Prepare clients for treatments safely and professionally, ensuring wellbeing, comfort and confidentiality. Apply risk assessments and adapt services to individual client needs.

Advanced Treatment Techniques

Perform and adapt advanced manual, facial, and body technical therapy treatments. Understand the physical and psychological effects of treatments and modify techniques to achieve bespoke treatment objectives.

Consultation & Planning

Conduct advanced consultations to design tailored treatment plans. Provide detailed post-treatment advice and recommendations to support client outcomes.

Product Knowledge & Sales

Promote and sell products, tools, and equipment appropriate for advanced treatments. Ensure recommendations align with client needs and treatment objectives.

Professionalism & Behaviours

Demonstrate ownership of work, professionalism, and effective communication. Act as an ambassador for the salon and the wider industry, supporting team development and client satisfaction.

APPRENTICESHIP ASSESSMENT

The Apprenticeship Assessment includes:

- A knowledge test demonstrating underpinning knowledge and Health & Safety/Legal requirements.
- An observation and technology assessment. The candidate will be required to complete a treatment log for submission based on treatments provided using all 15 technologies. The candidate will need to complete services and treatments on at least two clients (one must be existing). The services will include:
 - An advanced manual therapy consultation and an advanced manual therapy
 - Two technical therapy consultations
 - One advanced facial and advanced body treatment
- A professional discussion structures to draw-out the best of the candidate's competence and excellence.
- The total EPA time is 7.5 hours
